 - > The Bank reserves the right to require documented confirmation of the origin of funds when they are credited to clients' accounts;
 - > In case of limited technological capability the Bank reserves the right to process a client's cash order accepted after 14:00 (2:00 p.m. (post meridiem)) (Astana time) on the next transaction day (operation bank day), as well as the right not to accept a client's cash order on Friday after 15:00 (3:00 p.m. (post meridiem)) (Astana time) in case of limited technical capabilities;
 - > The Bank reserves the right to provide a statement at the client's request, received after 16:00 (4:00 p.m. (post meridiem)) (Astana time), on the next transaction day (operation bank day);
 - > The Client shall notify the Bank at least 2 (two) business days in advance (unless otherwise agreed with the Bank) about cash withdrawals in KZT (tenge), USD (US (United States) dollars), EUR (euro), GBP (Great Britain Pound) in the amount exceeding KZT (tenge) 10 000 000/USD (US (United States) dollars) 50 000/EUR (euros) 10 000 / GBP (Great Britain Pounds) 10 000;
 - > The Bank reserves the right to cover any additional fees of other banks at the expense of the client, if any;
 - > The Bank reserves the right to make changes to these tariffs unilaterally;
 - > The Bank does not provide services to persons who do not meet the Bank's internal requirements.
 - > Services and operations (transactions) carried out by the Client independently by using the "Altyn-i" service are tariffed (charged) within the approved Tariffs of "Altyn Bank" JSC (Join Stock Company) (SB (subsidiary bank) China CITIC Bank Corporation Ltd)) for individuals.
 - > In case of fees or services that are not reflected in these tariffs, please follow the General Banking Tariffs of JSC "Altyn Bank" (SB of China CITIC Bank Corporation Ltd.)
- ¹ Fee for maintenance of a dormant account is not debited from current accounts that participate in deposit agreements /loan agreements.
- ² Fee for cash withdrawal is not charged in case of holding money on the account for 15 or more calendar days.
- Fee for cash withdrawal operation (transaction) from current accounts is canceled in the following cases:
- from the amount of money converted from the amount in another currency which was previously on the client's deposit account /current account for at least 15 calendar days,
 - from the amount of money received by the client from the account of a *member of the family holding'*, that was previously on his/her deposit account / current account for at least 15 calendar days, *'members of the family holding – are the client's family members and attorneys.*
 - from the amount of money transferred from a current account /deposit account which was previously on another current account /deposit account for at least 15 calendar days.
